Ag Opportunities

- Nutrient Management Need more information need a format plan confusion on what is required (shuts down when hearing NM) Look for an extension to continue on NM planning acres with NFWF Funding. More counties interested just confusion on definition of NM and eligibility.
- Urban NM SWCD would like to be involved as they can be need to discuss how to pay districts for that work.
 - Keep SWCD up to date regarding outreach meeting this spring.
- RCPP Setup a meeting with the State Office regarding moving forward on this.

Buffer Opportunities

- Send MEB GIS layer to all counties so they know if their projects are in a priority area
- Fruit Trees Will landowners then manage their buffers?
 - Farmers/Landowners ask all the time if they can plant fruit trees Apple/Pears, etc.

Wetland Opportunities

- Availability of SRBC funding for wetland/flood attenuation/buffers/stream restoration. Beginning in 2022 has been available annually (January timeframe)- partners and members with projects sites that incorporate these practices and flood mitigation/attenuation let USC know and we can evaluate for possible grant application.
- Prioritizing wetland restoration on municipal lands in the watershed.
- Using wetland as a bargaining tool similar to buffers (we will support your farm practices, if you restore your wetland)
 - How do you ensure the commitment to the wetland if it is used as a trade off?
- Discussion of rental payments or incentive payments for wetlands.

Do counties prioritize buffers/wetlands in their counties for State Funding sources?

Opportunity for additional points if buffer and or wetland is planned.
